Clarification to the Notice dated 31.10.2020


In continuation of the previous notice dated 31.10.2020, notifying the fee structure for the school in terms of the judgment of the Hon'ble High Court of Calcutta in WPA No. 5890 of 2020 dated 13.10.2020, it is clarified that in terms of direction (vii) at paragraph 61 of the said judgment, all students whose parent/guardians are gainfully employed with the Government of West Bengal, the Government of India, or any Public Sector Undertaking (PSU) are requested to stand by the school during these trying times and continue to pay the entire amount of school fees as per Annexure II. Moreover, the parent/guardian of all students who are financially capable of paying the school fees in its entirety are also requested to co-operate with the school to tide over the financial crunch.

It is further clarified that the judgment and order dated 13.10.2020 passed by the Hon'ble High Court is presently under challenge before the Hon'ble Supreme Court without prejudice to the pending Special Leave Petition, any relief which may be granted by the Hon'ble Supreme Court to the parents/guardians across the board, shall duly be extended to all the parents/guardians, who have already paid the school fees in its entirety or who are willing to pay the same in its entirety, as per Annexure II and adjustments towards the same, shall be accordingly made in the school fees from the subsequent months (i.e. from January 2021 onwards) following the order of the Hon'ble Supreme Court of India.

The aforesaid clarification may be read as a part of the notice dated 31.10.2020.
