Regarding fees for the students of Classes Pre-Nursery to XII

Academic Session 2021-22

The new academic session commenced from April 2021 with lot of new hope of having a vibrant campus and lively interactive classrooms. But due to surge in Covid cases, we had to shift again to online classes. However, we hope to resume our classes in the campus as soon as the condition improves and Government allows us to do so.

The following points to be noted regarding the payment of fees in academic session 2021-2022:

- 1) There will be **no enhancement of fees in 2021-2022 till normal functioning of school resumes**. Any revision of fees is subject to reopening of schools/any Court directive, whichever is earlier.
- 2) The parents/ guardians of all students studying in Classes Pre Nursery to X and XII are hereby requested to pay the Session fees and monthly fees of 2021-2022, as shown in the given Table.

- 3) The students who have taken new admission in the academic session 2021-2022 (Classes Pre- Nursery, XI and in any other grades) will only pay the monthly fees from April onwards.

N.B.: *It is pertinent to mention that, in cases where the parents/guardians have already paid 100% fees till March 2021, in accordance with the fee schedule appended as **Annexure II**, the school will not be in the position to refund the said amount at this point of time, as the matter is sub judice before the Hon'ble Supreme Court.*

The school undertakes to adjust/refund the amount paid in excess of 80% of the fees against the fees payable for the period commencing in case of existing students and refund the same in case of students passing out, as the case may be, subject to the final judgment of Hon'ble Supreme Court.
